> Vices

The legal age to buy tobacco and nicotine vapor products increased from 18 to 21; establishments can now advertise happy hour drinks and prices; and lottery winners of \$10 million or more can remain anonymous.

▷ Schools

Public schools can now start two weeks before Labor Day, so long as they allow for a 4-day weekend for kids to go to Kings Dominion (no joke); private schools can hire "school resource officers" to carry firearms; students and teachers in public schools will receive training at least once a year on what to do in the event of an active shooter situation; school nurses can no longer be prosecuted for administering THC oil to students with doctors' notes; and school nurses (as well as other public workers) are now authorized to carry and administer the opioid reversal drug, Naloxone.



Virginia's first law on hands-free driving only applies to construction zones; children have to be in rear-facing car seats until they are 2 or reach the weight requirement; and you will now get a misdemeanor for "reckless driving" if you do not move over when someone is trying to pass you in the left lane.

> Fourth Amendment Alert

Police can use drones to look at the home of someone they have an arrest warrant for.

After Virginia State Trooper, Michael Walter, was fatally shot during a routine traffic stop and his killer only got 36 years in prison, Walter's widow heavily advocated for legislation that now includes murder of a police officer or public safety official in the line of duty in the definition of "capital murder," which carries a mandatory minimum sentence of life in prison (and the option of utilizing the death penalty).

▶ Tommie's Law

When a man tied his pit bull, Tommie, to a fence, doused Tommie in lighter fluid, and set him on fire, prosecutors could not bring charges against the owner until or unless Tommie actually died (under Virginia's prior anti-cruelty statute). While Tommie, sadly, did not survive his injuries, his memory lives on now that Virginia has made cruelty to animals a felony, regardless of whether the animal lives or dies, and perpetrators can be sentenced 1-5 years in jail,

▶ Heaven's Law

Doctors were concerned when 11-year-old Heaven Watkins came into the E.R. with a severe, suspicious burn on her hand, but Child Protective Services (CPS) released Heaven back into the care of her mother after a Virginia background check came up clear. Unbeknownst to CPS, Heaven's mother had pending child abuse charges in Minnesota, and a few months later, Heaven was tragically beaten to death by her mother and mother's boyfriend. CPS and similar agencies are now authorized and required to run background checks with other states before returning children to homes with potential abuse and neglect.

Professor Fiorentino's Fabulous Island Chocolate Chip Cookies

- ☐ 1 2/3 cups all-purpose flour
- ☐ 3/4 teaspoon baking powder
- ☐ 1/2 teaspoon baking soda
- ☐ 1/2 teaspoon salt
- ☐ 3/4 cup (1 1/2 sticks) butter or margarine, softened*
 - *Do not melt in microwave. It will change consistency of dough!
- ☐ 3/4 cup packed brown sugar
- ☐ 1/3 cup granulated sugar
- ☐ 1 teaspoon vanilla extract
- □ 1 large egg
- ☐ 1 3/4 cups milk chocolate chips

(I have also used white chocolate and chocolate/peanut butter)

PREHEAT Oven to 375° F.

COMBINE Flour, baking powder, baking soda and salt in small bowl. Beat butter, brown sugar, granulated sugar and vanilla extract in large mixer bowl until creamy. Beat in egg. Gradually beat in flour mixture. Stir in morsels. Place mixture in the fridge for 10-15 minutes to stop cookies from spreading while cooking. Drop by rounded tablespoon onto ungreased baking sheets. (I line them with parchment paper).

BAKE 8 to 11 minutes or until edges are lightly browned. Cool on baking sheets for 2 minutes; remove to wire racks to cool completely.
